In the review of a plan for the reorganization of school districts pursuant to the Learning Community Reorganization Act, the state committee shall give due consideration to (1) the educational needs of the learning community, (2) economies in administration costs, (3) the future use of existing satisfactory school buildings, sites, and play fields, (4) the convenience and welfare of pupils, (5) transportation requirements, (6) the equalization of the educational opportunity of pupils, (7) the amount of outstanding indebtedness of each district and proposed disposition thereof, (8) the equitable adjustment of all property, debts, and liabilities among the districts involved, (9) any additional statutory requirements for learning community organization, and (10) any other matters which, in its judgment, are of importance. The learning community coordinating council proposing the plan of reorganization, in preparation or review of a plan for reorganization, shall take into consideration any advice or suggestions offered by the state committee.

#### § 79-4,122. Public hearings; record; notice

Before any plan of reorganization submitted by a learning community coordinating council is approved by the state committee pursuant to the Learning Community Reorganization Act, the state committee shall hold one or more public hearings. At such hearings, the state committee shall hear any and all persons interested with respect to the areas of consideration listed in section 79-4,121. The state committee shall keep a record of all hearings in the formulation or approval of plans for the reorganization of school districts. Notice of such public hearings of the state committee shall be given by publication in a legal newspaper of general circulation in the county or counties in which the affected districts are located at least ten days prior to such hearing.

After one or more public hearings have been held, the state committee may approve a plan or plans of reorganization pursuant to the Learning Community Reorganization Act. Such plan shall contain:

(2) A summary of the reasons for each proposed change, realignment, or adjustment of the boundaries which shall include, but not be limited to, an explanation of how the plan complies with any statutory requirements for learning community organization and an assurance that the plan does not increase the geographic size of any school district that has more than twenty-five thousand students;

(3) A summary of the terms on which reorganization is to be made between the reorganized districts. Such terms shall include a provision for initial school board districts or wards within the proposed district, which proposed initial school board districts or wards shall be determined by the state committee taking into consideration population and valuation, and a determination of the terms of the board members first appointed to membership on the board of the newly reorganized district;

(4) A statement of the findings with respect to the location of schools, the utilization of existing buildings, the construction of new buildings, and the transportation requirements under the proposed plan of reorganization;

(5) A map showing the boundaries of established school districts and the boundaries proposed under any plan or plans of reorganization; and

(6) Such other matters as the state committee determines proper to be included.

(1) Within thirty days after the classification of the reorganized school districts by the county clerk under section 79-4,128, the state committee shall appoint from among the legal voters of each new school district created the number of members necessary to constitute a school board of the class in which the new school district has

been classified. A reorganized school district shall be formed and organized and shall have a school board not later than April 1 following the last legal action, as prescribed in section 79-4,128, necessary to effect the changes in boundaries as set forth in the plan of reorganization, although the physical reorganization of such reorganized school district shall take effect July 1 following the classification of the reorganized school districts under section 79-4,128. The first board shall be appointed on an at-large basis, and all boards shall be elected at large until such time as election districts are established as provided in section 32-554.

(2) In appointing the first school board of a Class II school district, the members shall be appointed so that the terms of three members expire on the date of the first regular meeting of the board in January after the first even-numbered year following their appointment and the terms of the three remaining members expire on the date of the first regular meeting of the board in January after the second even-numbered year following their appointment. At the statewide general election in the first even-numbered year after the reorganization, three board members in each Class II school district shall be elected to terms of four years. Thereafter all candidates shall be elected to terms of four years. Each member's term shall begin on the date of the first regular meeting of the board in January following his or her election.

(3) In appointing the first school board of a Class III school district with a six-member board serving terms of four years, the terms of three members shall expire on the first Thursday after the first Tuesday in January after the first even-numbered year following their appointment and the terms of the three remaining members shall expire on the first Thursday after the first Tuesday in January after the second even-numbered year following their appointment. Thereafter all Class III district school boards with six-member boards shall be elected to terms of four years.

(4) In appointing the first school board of a Class III school district with a nine-member board serving terms of four years, the terms of four members shall expire on the first Thursday after the first Tuesday in January after the first even-numbered year following their appointment and the terms of five members shall expire on the first Thursday after the first Tuesday in January after the second even-numbered year following their appointment. Thereafter all Class III district school boards with nine-member boards shall be elected to terms of four years.

(5) In appointing the first school board of a Class IV school district, the members shall be appointed so that the terms of three members shall expire on the third Monday in May of the first odd-numbered year following their appointment and the terms of four members shall expire on the third Monday in May of the second odd-numbered year following their appointment. Thereafter all Class IV

district school boards shall be elected to terms of four years.

(6) In appointing the first school board of a Class V school district with a twelve-member board serving terms of four years, the terms of six members shall expire on the first Monday in January after the first even-numbered year following their appointment and the terms of six members shall expire on the first Monday in January after the second even-numbered year following their appointment. Thereafter all Class V district school boards shall be elected to terms of four years.

(7) The school boards appointed under this section shall proceed at once to organize in the manner prescribed by law.

- b. one who shall be selected and appointed by the collective bargaining units representing the certificated staff (teachers and nurses); and,
- c. one who shall be selected and appointed by the collective bargaining unit representing the custodial and maintenance staff; and,
- d. one who shall be selected and appointed by the collective bargaining unit representing the educational paraprofessionals; and,
- e. one who shall be selected and appointed by the secretarial, food service and SPED van driver and other staff.

The safety committee will operate within the guidelines established by the Nebraska Department of Labor for injury prevention programs. Each school principal shall be responsible for implementing the district safety program in his or her building. The Superintendent will assign an administrator the responsibility for implementing the district safety program in each of the district's non-school buildings.

### **Pupil Services**

### Discipline of Students under Section 504 of the Rehabilitation Act of 1973

- I. <u>General Statement</u>. Suspension and expulsion of eligible disabled students under Section 504 of the Rehabilitation Act of 1973 shall comply with District procedures and federal and state statutes, regulations, and rules.
- II. <u>Eligible Disabled Students</u>.
  - A. <u>Eligible disabled students defined</u>. An eligible disabled student is any student between the ages of five (5) and twenty-one (21) who has not graduated, and who has been determined by a District 504 Committee to qualify as disabled under Section 504, and for whom the District has made available an accommodation plan. a physical or mental impairment which substantially limits one or more major life activities, or has a record of such an impairment, or is regarded as having such an impairment.
  - B. <u>Physical or mental impairment defined</u>. Physical or mental impairment means any physiological disorder or condition, cosmetic disfigurement, or anatomical loss affecting one or more of the following body systems: neurological; musculoskeletal; special sense organs; respiratory, including speech organs; cardiovascular; reproductive, digestive, genito urinary; hemic and lymphatic; skin; and endocrine; or any mental or psychological disorder, such as mental retardation, organic brain syndrome, emotional or mental illness, and specific learning disabilities.
  - C. <u>Substantially limits defined</u>. Substantially limits is not defined by Section 504 nor Title II and is subject to interpretation on a case by case basis. Title II provides three factors which characterize the term "substantially limits": the nature and severity, the duration or expected duration, and the permanent or long term impact of the impairment.
  - D. <u>Major life activities defined</u>. Major life activities means functions such as caring for one's self, performing manual tasks, walking, seeing, hearing, speaking, breathing, learning, and working.
  - E. <u>Has a record of such impairment defined</u>. Has a record of such an impairment means has a history of, or has been misclassified as having a mental or physical impairment that substantially limits one or more major life activities.
  - F. <u>Regarded as having an impairment defined</u>. Regarded as having an impairment means has a physical or mental impairment that does not substantially limit major life activities but that is treated by the District as constituting such a limitation; has a physical or mental impairment that substantially limits major life activities only as a result of the attitudes of others toward such impairment; or has none of the impairments defined in paragraph B above but is treated by the District as having such an impairment.

#### III. Expulsion.

- A. <u>Expulsion defined</u>. For the purposes of this Rule, any exclusion from school for more than ten (10) school days at one time shall be deemed an expulsion from school and a significant change in placement.
- B. <u>Section 504 Committee manifestation determination</u>. Before a disabled student is expelled from school, the student's 504 Committee will convene to determine whether the student's misconduct was a manifestation of the student's disability.

- C. <u>Manifestation determination</u>. In carrying out a manifestation determination, the 504 Committee may determine that the misconduct of the student was not a manifestation of the student's disability only if:
  - 1. The 504 Committee first considers, in terms of the misconduct which is the subject of the disciplinary action, all relevant information in the student's file, any teacher observations, any relevant information supplied by the parents of the student, and the student's Individual Aaccommodation Pplan (IAP) and placement.
  - 2. The 504 Committee then determines if the conduct in question was caused by or had a direct and substantial relationship to the student's disability or if the conduct in question was the direct result of the District's failure to implement the student's IAP accommodation plan.
  - 3. If the 504 Committee determines that any of the standards in the immediately preceding <u>Section III(C)(2)</u> paragraph C (2) were not met, then the misconduct must be considered a manifestation of the student's disability.
- D. <u>Behavior not a manifestation of the disability</u>. If the 504 Committee determines that the misconduct is not a manifestation of the student's disability, then the student may be excluded from school pursuant to the procedures set forth herein and in District Rule 5400.1. If a student is excluded pursuant to District Rule 5400.1, then the student shall be eligible for academic credit upon successful participation in and completion of alternative school, classes, or programs pursuant to District Rule <u>5400.5</u>–<u>5400.6</u>. When a student so participates in alternative school, classes, or programs pursuant to District Rule <u>5400.5</u>–<u>5114.6</u>, the student's 504 Committee shall convene to consider appropriate changes to the student's <u>IAP accommodation plan</u>.
- E. <u>Behavior which is a manifestation of the disability</u>. If the 504 Committee determines that the misconduct is a manifestation of the student's disability, then the student may not be excluded for more than ten (10) school days. The 504 Committee will determine whether the student's current educational placement and related aids and services contained in the student's current IAP are appropriate. If deemed inappropriate, then changes to the IAP will be considered by the 504 Committee.
- F. <u>Expulsion procedures</u>. When a disabled student is excluded from school for more than ten (10) school days, the student and the student's parent are entitled to Section 504's procedural rights including an opportunity for the examination of records, an impartial hearing (with participation of parents and opportunity for counsel), and review by an independent reviewer. In those cases where parents disagree with the manifestation determination, or with the subsequent placement and related aids and services decisions (in those cases where the misconduct is determined to be a manifestation of the disability), they may then request an informal conference or due process hearing as set forth in Sections VII through X below.
- G. <u>Alternative Education Program</u>. Expelled disabled students will have available alternative education pursuant to District rule 5400.5.
- IV. Drugs and Alcohol.

The District shall take disciplinary action pertaining to the use or possession of illegal drugs or alcohol against any student who is an individual with a disability and who currently is engaging in the illegal use or possession of drugs or in the use or possession of alcohol, to the same extent that such disciplinary action is taken against students who are not individuals with disabilities. The procedural safeguards provided in 34 C.F.R. § 104.36 and in Section III (F) above and Sections VII through XI below, shall not apply to such disciplinary actions.

V. <u>Suspension</u>.

- A. <u>Behavior which is a manifestation of the disability</u>. A student may be suspended from school for ten (10) school days or less, even if the student's misconduct is a manifestation of the student's disability.
- B. <u>Suspension not a change in placement</u>. A suspension of ten (10) school days or less at one time does not constitute a change of placement; however, if a student is suspended for more than ten (10) cumulative school days during the school year, then the 504 Committee shall convene for each subsequent suspension to review and determine the appropriateness of the student's <u>IAP</u> accommodation plan.
- C. <u>Suspension conditions and procedures</u>. A suspension of five (5) school days or less shall follow the conditions and procedures for a short-term suspension set forth in District Rule 5400.1. A suspension of more than five (5) school days, but not more than ten (10) school days, shall follow the conditions and procedures for a long-term suspension set forth in District Rule 5400.1.
- VI. <u>Emergency Exclusion</u>.

A disabled student may be subject to emergency exclusion for the reasons and pursuant to the procedures set forth in District Rule 5400.1.

VII. <u>Informal Conference</u>.

Parents and students of majority age may file with the school principal a written request for an informal conference to discuss suspension, expulsion, or the manifestation determination. Within ten (10) school days of the receipt of the request, the principal will convene an informal conference team consisting of the parents, school administrators, and the student's 504 Committee to attempt to resolve any disagreements.

- VIII. Preliminary Procedures for Formal Hearings.
  - A. The following rules apply for formal hearings:
    - 1. The student's parents must file a written request with the District's Director of Pupil Services for a formal due process hearing with respect to the suspension or expulsion of their child, or the manifestation determination. The written request must include an explanation of the parents' concern related to the suspension, expulsion, or manifestation determination.
    - 2. If a formal hearing is requested, the Director of Pupil Services will appoint an impartial hearing officer. The hearing officer shall not be a witness at the hearing, must have no involvement in the case, must not be a District employee, and must be available to answer any questions relative to the hearing. The District, however, may pay the hearing officer as an independent contractor.
    - 3. The hearing must be held within twenty (20) school days after a parent's initial request for a hearing, but cannot be held without providing the principal and the student's parents at least five (5) school days prior notice.
    - 4. The student's parents or representative shall have the right to examine the records and written statements (including the statements of any witnesses for the District) at a reasonable time prior to the hearing.
    - 5. The hearing officer will also be available preceding the hearing to answer questions concerning the nature and conduct of the hearing.
- IX. The following rules apply when a formal hearing is conducted:

- A. The following shall attend the hearing: the hearing officer, the principal (or designee), the student's parents, and the student's representative (if any). The principal and Board may also have counsel present.
- B. Witnesses may be present only when giving information at the hearing.
- C. The hearing shall be closed to the public. The decision shall be treated as a record of the student, and will not be made available to the public.
- D. The student may be present if requested by the parents; however, the hearing officer may exclude the student at times when the student's psychological evaluation or emotional problems are being discussed.
- E. The principal shall present statements, in affidavit form, to the hearing officer of anyone having information pertinent to the case only if the affidavits have been made available to the student's parents or representative prior to the hearing.
- F. The hearing officer is not bound by the rules of evidence or other rules of courtroom procedure.
- G. The following persons may ask persons to testify at the hearing: the student; the student's parents or representative; the principal (or designee); and the hearing officer.
- H. The persons listed in the preceding paragraph shall have the right to question any witness giving information at the hearing.
- I. The testimony shall be under oath and the hearing officer shall administer the oath.
- J. Any person giving testimony is given the same immunity from liability as a person testifying in a court case.
- K. The hearing shall be recorded at District expense.

#### X. <u>Decision of the Hearing Officer</u>.

- A. The decision of the hearing officer shall conform with the following:
  - 1. It shall be issued within ten (10) school days after the hearing. It will contain findings of fact, a decision of the action(s) to be taken, and the reasons <u>therefor</u> therefore. The decision will be based solely upon the evidence presented at the hearing.
  - 2. Written notice of the decision of the hearing officer shall be sent by the Director of Pupil Services, by registered or certified mail, or by personal delivery, to the student's parents.
- B. Upon receipt of the written notice, the hearing officer's decision shall take effect.
- XI. <u>Review Procedure</u>.
  - A. Either the complainant or the school may appeal the decision of the hearing officer to an independent reviewer appointed by the Director of Pupil Services. The independent reviewer must not be a witness at the hearing, must have no involvement in the case, and must be available to answer any questions relative to the hearing. The independent reviewer cannot be an employee of, or under contract with the District. Payment to the independent reviewer for his/her services does not make the reviewer an employee of, or under contract with the District.
  - B. A written request for appeal must be filed with the Director of Pupil Services-within five (5) days of the receipt of the written notice of the decision of the hearing officer. A request for appeal

must be based on an alleged error of fact or law, and the written request must explain the reasons for the appeal and the alleged error of fact or law.

- C. The non-appealing party may file a written response with the independent reviewer within five (5) school days of that party's receipt of the written request for appeal.
- D. The independent reviewer shall hold a hearing within twenty (20) school days of the filing of the written request for appeal, but such hearing cannot be held without providing all parties with at least five (5) school days notice. The proceedings of the hearing shall be limited to the presentation of oral arguments regarding the alleged errors of fact or law. The independent reviewer is not bound by the rules of evidence or other rules of courtroom procedure.
- E. The independent reviewer will complete the review and issue a written decision within ten (10) school days of the hearing. The independent reviewer has the authority to revise the findings and decision of the hearing officer and the decision of the independent reviewer will be final.

### **Search and Seizure**

Certificated staff members are permitted to search students or students' possessions whenever there is a reasonable suspicion that the student has in the student's possession illegal, dangerous or any other object the possession of which is contrary to District Policy, governing law, or when necessary for the welfare and well-being of students, protection of District property, or the administration of District Policy.

School lockers are the exclusive property of the District and may be opened or searched by certificated staff members without notice and without student consent.

Certificated staff members may seize and take custody of any objects or substances found during a search whenever such objects or substances are dangerous, contrary to law or school policy, or which may threaten the welfare of students, school personnel, or District property.

The refusal of a student to consent or submit to a reasonable search and/or to surrender objects or substances found as a result of such search may be grounds for discipline.

### **Pupil Services**

### **Search and Seizure**

- I. <u>General Statement</u>. Certificated staff are authorized to conduct searches of a student's person, clothing, automobile, and property under a student's control including, but not limited to, purses, handbags, book bags, and briefcases. Certificated staff are also authorized to search student lockers. Certificated staff may take into custody any objects or substances that are illegal under federal or state law, or in violation of District Policy or Rule.
- II. <u>Procedures for Non-District Property</u>. The following procedures shall be followed with respect to searches and seizures under this Rule:
  - A. <u>Reasonable Searches Permitted.</u>
    - 1. Searches of non-District property are to be conducted at such times and places as are reasonable under the circumstances. The scope of the search shall likewise be reasonable.
    - 2. Searches can be made under this Rule at any place on District property, at a District event, or at a place under District control or sponsorship.
  - B. Person, Clothing, Automobiles, Personal Possessions, and Field Trips.
    - 1. A search of a student's person, clothing, automobile, personal property or possessions will only be made if there is reasonable cause to believe that the student has possession or control of an illegal object or substance that is illegal under federal or state law, or in violation of District Policy or Rule.
    - 2. A search of the person, clothing, automobile, personal property or possessions shall be made, whenever practicable, by two certificated staff members. When the search is made of the student's person, the search shall be conducted only by staff members of the same sex as the student being searched.
    - 3. Prior to leaving on a field trip or other off-campus activity sponsored or participated in by the District, the District may search any baggage, purses, or other containers in the possession of or under the control of a District student participating in the field trip or other off-campus activity.
- III. <u>District Property: Student Lockers</u>. Student lockers are the exclusive property of the District and the District does not relinquish its control and ownership of lockers by making them available for students. Student lockers are provided to students only for student convenience, and this privilege may be withdrawn by the District at any time. The search and inspection of lockers and the taking into custody of objects or substances which are illegal or in violation of District Policy or Rule may be conducted at any time by certificated staff without notice and without student consent. Whenever practicable, two certificated staff members shall be present at the time locker searches are conducted.
- IV. <u>Enforcement of this Rule</u>. The refusal by a student to consent to or permit a search, or the refusal to surrender objects or substances which are illegal or violate District Policy or Rule, may subject such student to suspension, expulsion, or other disciplinary action.
- V. <u>Law Enforcement Authorities</u>. Police officers and other law enforcement authorities shall be permitted to conduct a search of a student, the student's clothing, and the student's possessions and property on District property, at a District event, or at a place under District control whenever such officers or authorities:

### 5480.1

- A. Possess a judicial order providing for the same;
- B. Are otherwise authorized by law to make a search; or
- C. Exigent circumstances exist.
- D. Neither school officials nor staff members shall participate directly or indirectly in any search or actions relating thereto conducted by a police officer or law enforcement official.

### **Pupil Services**

### **Searches by Sniffer Dogs**

- I. <u>Purpose</u>. The District shall use trained sniffer dogs to detect illegal drugs or contraband on school property. The purpose of the District's use of sniffer dogs is to respond to the problem of illegal drugs and contraband on school property, and to maintain a safe school environment conducive to learning.
- II. <u>Types of Searches</u>.
  - A. <u>Search of Property</u>. Sniffer dogs may be used to sniff the air in or around vacant classrooms, vacant common areas, student lockers, and automobiles parked on school property. If the dog alerts to a particular locker, car, and/or an object(s) in a vacant classroom or other vacant common areas, it may be searched. If the dog alerts to a student's car, the student will be asked to unlock the car doors and trunk for an internal inspection. If the student refuses to unlock the car or trunk, the student's parents or guardian shall be notified of the student's refusal.
  - B. <u>Search of Students</u>. Sniffer dogs will not be used for random sweep searches of students, and will only be allowed to sniff an individual student if there is sufficient cause to believe that the student possesses illegal drugs or other contraband. If sufficient cause exists and the sniffer dog alerts to a student suspected of having illegal drugs or contraband, the student's outer garments and/or purse or personal belongings shall be subject to search. If a pat search is necessary, it will be conducted by someone of the same sex as the suspected student.
- III. <u>Notice of Use of Sniffer Dogs</u>. District students and their parents or guardian will be notified annually of the District's use of sniffer dogs. The notice will include the following information:
  - A. That the District may use sniffer dogs to detect illegal drugs and/or contraband at any time, announced or unannounced;
  - B. That lockers remain under the jurisdiction of the District, and that although lockers are used by students during the school year, lockers are owned by the District and are subject to a sniff search at any time. That illegal objects or substances found in lockers may be seized.
  - C. That all cars parked on school property shall be subject to a sniff search at any time, and that illegal objects or substances may be seized.
  - D. That students shall be subject to a sniff search if there is sufficient cause to believe that a student possesses illegal drugs or contraband.
  - E. That classrooms and all common areas are subject to a sniff search at any time whenever students are not present.
  - F. That if any illegal drugs or contraband are found on a student's person, or in his/her automobile, locker, or any other place on school property that the student has placed illegal drugs or contraband, the student may be subject to appropriate disciplinary action, including suspension or expulsion.
  - G. That students' parent(s) or guardian(s) shall be notified if illegal drugs or contraband are discovered.
- IV. <u>Disciplinary Action</u>. Students who are found to be in violation of this Rule shall be subject to appropriate disciplinary action, including short-term suspension, emergency exclusion, long-term suspension, mandatory reassignment, expulsion, and/or curtailment from extracurricular activities.

### V. <u>Definitions</u>.

- A. <u>Alerts to shall mean an indication by the sniffer dog that the odor of an illegal drug or contraband is in the air or upon a student.</u>
- B. <u>Contraband</u> shall mean all items prohibited by federal, state, or local law, or by District Policy or Rule from being brought onto school property including, but not limited to, drug paraphernalia as defined in District Rule 5410.1, guns, and knives.
- C. <u>Illegal drugs</u> shall mean those substances defined in District Rule 5410.1 under Section III (B) (2) "Mood or behavior affecting substances", and any other drug which is illegal according to federal, state or local law.
- D. <u>Outer garments</u> shall mean all clothing (slacks, trousers, dresses, shoes, hats, coats, gloves, etc.) except the student's undergarments.
- E. <u>Sufficient cause</u> shall mean "reasonable cause" in the event the search is conducted by certificated staff of the District or its authorized agent, or "probable cause" if the search is conducted by police officers or other law enforcement authorities.

#### Millard Public Schools 2010 Commercial Insurance Risk Management Report

Millard Public Schools' property and casualty insurance program renewed in 2010 with positive financial results. We marketed (bid) Millard's insurance program to numerous (22) workers' compensation and multi-line package markets (exhibit 1& 2). There were no material changes in coverages, deductibles, or limits within the overall program. There was one coverage enhancement in regard to pollution/mold liability. After the competitive premium and coverage comparison, the incumbent carriers prevailed and they remain to be United Heartland for workers' compensation, Travelers for package, and Chartis Insurance Group for the School Board E & O and Network Security policies.

While the cost of risk continues to be positive for Millard Public Schools overall, we did have an increase of premium in the workers' compensation line due to adverse loss ratios. However, the workers' compensation premium per \$100 of payroll remains to be below 2007 costs as a percentage of payroll(see historical trend analysis – exhibit 3). The previous policy years of 2008 and 2009 provided a savings of over \$300,000 compared to market pricing. The 2010 property and liability policies continue to decrease in rate due to good loss experience and a larger exposure basis. Despite the increase in the workers' compensation area, Millard Public Schools overall cost of risk remains to be below national peer averages comparisons by 3.2% (Risk and Insurance Management Society, Inc. 2010 Report).

The 2010 year risk management activities were significant in time and results. Below is a highlight of these activities:

- Comprehensive Risk Analysis<sup>©</sup> was performed which consisted of numerous meetings with MPS administrators and department mangers. All perceived exposures to risk were analyzed along with appropriate coverage and or retention.
- Risk Analysis of information technology network security with respects to breach of privacy and crisis management
- Enhancement of Pollution/Mold Liability insurance with limits of \$1,000,000
- Quarterly claim reviews
- Loss Control inspections of schools and the design of a school risk identification checklist
- Ongoing loss control awareness meetings with Administrators, Sodexo and staff.
- Review of MPS's contractual risk transfer for selected vendors, suppliers, contractors including First Student Transportation Interlocal agreement.

The 2010 insurance market remained soft with competitive premiums, coverages, and terms for urban school districts in Nebraska and nationwide. The market for school districts is considered stable with strong competitors and good financial results. At this time, Millard is insured by

companies that are considered industry leaders in terms of coverage, services and expertise in educational risks.

While Millard has seen some decreases in their historical frequency of workers' compensation claims, per claim severity costs have been on the rise (exhibit 4). This following year in 2011, Nebraska base rates for education risks are increasing 5.7%. In addition, Millard's experience modification factor will see some upward pressure of approximately 6%. We anticipate these two factors will provide upward pricing pressure for Millard's workers' compensation premium in 2011. However, we feel we can moderate any rate increase with continued safety and loss prevention efforts and market competition.

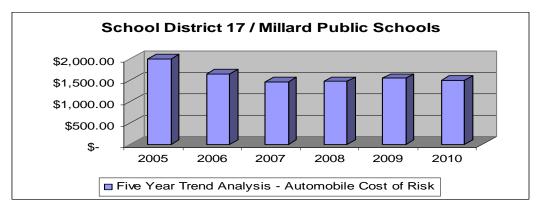
#### School Dist #17 Premium Comparison











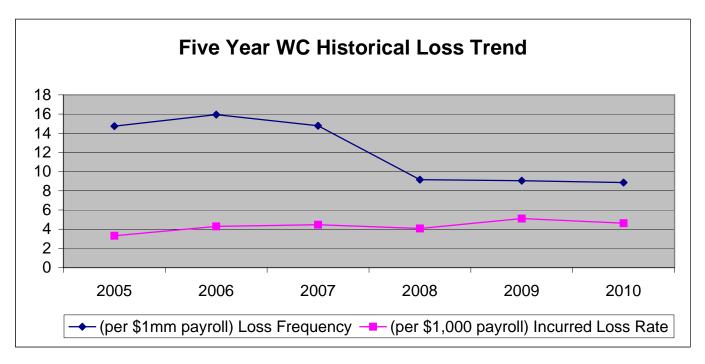

#### **BACKGROUND:**

Attached are the end-of-the-year site plan reports for Millard North, South, West and Horizon High School. The principals will be on hand to give you a brief summary of their plan and answer any questions you may have.

All schools are on a cycle for site planning. This cycle allows us to allocate resources to help facilitate their school site planning process. This cycle is planned in conjunction with the North Central Accreditation (NCA) school improvement cycle. The NCA has accepted our strategic and site planning process as our school improvement process so we no longer have to run two systems. The attached site plan reports are descriptions of the individual site plans and a summary of school improvement meetings.

Schools follow the same basic schedule that the district follows in strategic planning. They meet to write a plan, form action teams, work for 3-4 months to develop action plans, and then meet again to approve those action plans. Schools implement plans over 4 years. Schools write a plan, implement the plan the next year then update the plan the following year. This is one way we align all site plans with district plans. You will notice that mission statements and objectives are all aligned with the district mission and objectives.

The attached reports identify the school improvement team members from each school. The report also lists the mission, objectives and strategies for the building. Each report also highlights action plans for each strategy. The last section of the report lists consensus items on major decisions for the school including things like schedule, calendar decisions, parent/teacher conferences and the allocation of building resources. Our system of support for sites includes training CADRE Associates Jane Pille and Chris Wilcoxen to facilitate planning and updates as needed. This process is outlined in policy 10,000 and rule 10,000.1. The policy and rule are reviewed every other year.
