## Committee Meeting Minutes June 10, 2013

The members of the Board of Education met as a Committee of the Whole on Monday, June 10, 2013 at 6:00 p.m. at the Don Stroh Administration Center, 5606 South 147<sup>th</sup> Street.

Present: Patrick Ricketts, Dave Anderson, Mike Pate, Paul Meyer, Mike Kennedy and Linda Poole

Patrick Ricketts called the meeting to order at 6:00 p.m.

Ken Fossen presented a historical overview of District finances followed by a review of projected revenue and expenditures for the 13-14 fiscal year.
