A meeting of the Board of Education of the School District No. 17, in the County of Douglas in the State of Nebraska was convened in open and public session at 6:00 p.m., Monday, February 17, 2014, at the Don Stroh Administration Center, 5606 South 147th Street.

Notice of this meeting was given in advance thereof by publication in the Daily Record on Friday, February 14, 2014; a copy of the publication is being attached to these minutes. Notice of this meeting was given to all members of the Board of Education and a copy of their Acknowledgment of Receipt of Notice and the agenda are attached to these minutes. Availability of the agenda was communicated in advance notice and in the notice of the Board of Education of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

President, Pat Ricketts, announced that the open meetings laws are posted and available for public inspection. Mr. Ricketts asked everyone to join in the Pledge of Allegiance.

Roll call was taken: Dave Anderson, Pat Ricketts, Mike Kennedy and Paul Meyer were present.
Absent was: Mike Pate and Linda Poole

Mr. Ricketts announced that Mr. Pate and Mrs. Poole had notified the Board that they would be absent from the meeting.

President Ricketts announced the proper time for public questions and comments on agenda items only. There were no questions or comments.

Motion was made by Mike Kennedy, seconded by Paul Meyer, to approve the Board of Education Minutes from February 3, 2014 and receive the treasurer's report and place on file. Voting in favor of said motion was: Mr. Kennedy, Mr. Meyer, Mr. Anderson and Mr. Ricketts. Voting against were: None. Motion carried.

Employees of the Month were Cheryl Decker, SPED Preschool teacher at Cody Elementary and Jill Fiala, Administrative Assistant at Millard North High School.

Superintendent's Comments:

1. There will be no Committee meeting in March. The Board members will be meeting with the Superintendent search firm on that week of the Committee meeting. Dr. Lutz had a chance to visit with the person in charge at PROACT last week and gave him some back ground on the district.
2. We need to start thinking about the first Board meeting in April. Five of the Board members will be at a conference in New Orleans and will not be here. At that meeting, the new Superintendent was to be named. We need to think about moving that meeting to a different date.

Board Comments:

Dave Anderson stated it is elementary school reading month in the schools because the invitations to read are coming out. He also said he saw no reason why the Superintendent would have to be named on the first. That date could be moved.

Mike Kennedy attended the National Legislative conference with NSBA in Washington D.C. last week and gave a report on his lobby for our delegation on the Hill.

Paul Meyer reported that he received a couple of phone calls regarding students taking "selfie pictures" with their cell phones that are pornographic. These pictures are being sent around during class time and Mr. Meyer feels something should be done to have it stopped. He is wondering if this falls under disruptive behavior in one of our policies and if the policy is not strong enough to handle this behavior, then maybe the Board needs to look at it again.

Pat Ricketts has been practicing his reading to get ready for the elementary reading month. The Board is scheduled to meet with PROACT on March 10th and set the times for interviews on March 13th and 14th.

New Business:

A motion was made by Dave Anderson and seconded by Mike Kennedy to adopt the Analytic Writing Assessment ELO Cut Scores for 3rd and 5th Grades. Mark Feldhausen gave an explanation on how "cut-scores" are established. Voting in favor of said motion was: Mr. Meyer, Mr. Anderson, Mr. Ricketts and Mr. Kennedy. Voting against was: None. Motion carried.

Motion by Mike Kennedy and seconded by Dave Anderson to approve Rule 2100.20 – Administration – Administrator Job Description – Director of Digital Learning. Mr. Meyer felt that this position was not necessary and a waste of tax payer money. He stated that Millard hasn't had this position in the past and wondered why this job could not be spread out and handled by a few people. It was explained that Millard has been doing just that the past several years and the district is behind in the conversion too digital learning. Dave Anderson stated that hiring for this position fits into our strategic plan. Voting in favor of said motion was: Mr. Ricketts, Mr. Kennedy and Mr. Anderson. Voting against was: Mr. Meyer. Motion carried.

Motion by Mike Kennedy and seconded by Dave Anderson to approve the Construction Documents for Aldrich Elementary Project. Nicolette Amundson was present to address questions from the Board. Voting in favor of said motion was: Mr. Anderson, Mr. Ricketts, Mr. Kennedy and Mr. Meyer. Voting against was: None. Motion carried.

Motion by Dave Anderson and seconded by Mike Kennedy to award the contract for the Black Elk Elementary School Additions Project to Prairie Construction Company in the amount of \$1,689,000 and that the Associate Superintendent for General Administration be authorized and directed to execute any and all documents related to such project. Jon Carlson of Carlson West Pavondra was present to address questions from the Board. Voting in favor of said motion was: Mr. Kennedy, Mr. Meyer, Mr. Anderson and Mr. Ricketts. Voting against was: None. Motion carried.

Motion by Mike Kennedy and seconded by Dave Anderson to award the contract for the Cottonwood Elementary School Additions Project to Prairie Construction Company in the amount of \$380,000 (with such amount including the Base Bid and Alternate #1) and that the Associate Superintendent for General Administration be authorized and directed to execute any and all documents related to such project. Mike Purdy of Purdy & Slack was present to address questions from the Board. Voting in favor of said motion was Mr. Ricketts, Mr. Kennedy, Mr. Meyer and Mr. Anderson. Voting against was: None. Motion carried.

Motion by Mike Kennedy and seconded by Dave Anderson to award the contract for the Millard North High School Swimming Pool Project to Lueder Construction in the amount of \$1,860,000 (with such amount including the Base Bid only) and that the Associate Superintendent for General Administration be authorized and directed to execute any and all documents related to such project. Jim Torres from DLR Architects was present to address questions from the Board. Voting in favor of said motion was Mr. Meyer, Mr. Anderson, Mr. Ricketts and Mr. Kennedy. Voting against was: None. Motion carried.

Motion by Mike Kennedy and seconded by Dave Anderson to approve as follows: (1) that the low bidder for the Millard South High School Switch Gear Project be permitted to withdraw its bid due to an error in its submittal; (2) that the contract for such project be awarded to Omaha Electric Service Inc. in the amount of \$138,411 for the base bid only; and, (3) that the Associate Superintendent for General Administration be authorized and directed to execute any and all documents related to such project. Andy Lang with Morrissey Engineering Inc. was present to address questions from the Board. Voting in favor of said motion was: Mr. Kennedy, Mr. Meyer, Mr. Anderson and Mr. Ricketts. On February 18, 2014 at 2:30 pm bids were publicly opened for the Millard Central Middle School Erosion & Drainage Improvements – Phase II. Bids were received from Linhart Construction and JV5 Solutions.

The Engineer's Estimate for this work was \$160,250.00 for the project. The estimate was developed on a block and grid wall system consisting of small segmental block and geogrid for stability. The total square feet of the estimated wall was 1,550. Upon review of the geotechnical report and the proposed erosion control measures the proposed wall block system needed to be altered to large gravity block system (Stone Strong System) without geogrid. These changes also increased the overall square footage of the wall to 2,352.

Linhart Construction provided a low base bid total of \$209,204.60. They also provided a value engineering alternate that would use an alternate large gravity block system (Recon System) that would reduce the total project price by \$17,532.53. Legislative Update

March 3, 2014

Legislative Issues

All hearings are now completed. The bills have been prioritized by a senator, committee or the speaker. Full day debate will begin on March 4. There are 24 days left in this session.

LB 276 (Nordquist) provides funding for federal Medicaid for special education funds to carry out provisions of the Early Intervention Act. This will fund a previously unfunded mandate.

LB 438 (Adams) provides for priority schools, operating councils, and community schools where intervention teams would be assigned.

LB 464 (Ashford) creates a council on student attendance to consider school district attendance policies and make recommendations for improvement. It also calls for a grant program for districts to access to reduce absenteeism and truancy.

LB 670 (McCoy) changes property tax valuations for agricultural land from 75% to 65%

LB 725 (Sullivan) advanced on initial debate. This bill increased state aid for MPS about 3 million.

LB 923 (McGill) requires at least one hour of suicide awareness and prevention training each year for nurses, counselors, teachers, and administrators.

LB 967 (Education Committee) was heard in the Education Committee. This bill will phase out aid for instructional time and teacher education.

LB 972 (Lautenbaugh) adopts the Independent Schools Act

LB 1103 (Sullivan) calls for a strategic planning process. Senator Sullivan refers to it as a visioning process to establish Educational goals that will then drive the future formula.

The bills in **yellow** have been prioritized for the session and will be debated. The other bills will not likely be debated this year. All bills that remain in committee this session will be dispensed with and will have to be reintroduced next year. I have attached the bills we are supporting and the ones we oppose. We are also monitoring a number of bills.

National News

5 tech trends predicted to transform teaching, learning

Augmented reality, extreme bring-your-own-device programs, big data, the semantic web and transmedia storytelling are poised to change teaching and learning, according to educational futurist Jason Ohler. Speaking recently at the International Society for Technology in Education's virtual conference, Ohler offered

the example of BYOD, saying the trend is taking off beyond laptops and tablets, predicting that wearable technology will be used in the future

Blended learning creates new roles for educators

The growing popularity of blended learning in education has led to establishing "coach" or "success coach" roles -- staff who support and offer guidance to students engaged in blended learning. Such personnel act as counselors, mentors and more. "[There is] one educator whose sole role and responsibility is ensuring students learn in a positive, supportive, safe, and collaborative environment.

Districts opt for blended learning to teach on snow days

Districts nationwide are moving to a blended-learning model when severe weather prevents students from coming to school. Chicago recently took advantage of online coursework during snow days, and in a New Hampshire district, a snow day counts as an instructional day if 80% of students and staff participate in online instruction. In response to expected storms, districts in Ohio can give out "blizzard bags," which contain printed copies of educational materials in case students lack access to the Internet
