BACKGROUND: Millard's current Class Rank calculation was established in 2000 to encourage students to take more classes. In recent years, building principals and District administrators have noted increasing concern over the Class Rank formula. These concerns have resulted in a review of the need for a Class Rank calculation and the exploration of alternatives. Before bringing any recommendation forward a conversation with the Board of Education is warranted.

BACKGROUND

- ❑ The current Class Rank calculation within Millard Public Schools was last revisited during the 1999-2000 school year and approved by the Board of Education on April 24, 2000, to assist with maximizing the number of courses students would take within a school year.
- ❑ While other Graduation Requirement changes have been approved by the Board of Education since that time, class rank calculation has remained the same.
- ❑ Within the past several years, changes related to class rank practices have surfaced nationwide, as well as within the District.

CURRENT PRACTICES - BOE RULE 6330.1

The Grade Point Average is calculated by dividing total grade points by total course credits attempted.

CURRENT PRACTICES - BOE RULE 6330.1

- To determine Class Rank, the Grade Point Average is multiplied by the total Grade Points which equal Total Class Rank Points for each student.
- The listing of the Total Class Rank Points from highest to lowest shall determine the Class Rank of each student.

$$\text{GPA} \times \text{total Grade Points} = \text{Total Class Rank Points}$$

WHY REVISIT CLASS RANK?

- Conversations with students, parents, staff, and graduates over the past six years helped determine it was time to review our practices.
- Research began in October, 2013 to ensure all aspects regarding class rank were reviewed.
- Information was gathered from other school districts, post-secondary institutions, professional organizations, and research reviews.
- During the study input was sought from high school administrators, counselors, parents of seniors and graduating seniors.

IDENTIFIED CONCERNS

- ❑ Equity of opportunity: Summer School and Transfer Credit
 - “Please remove summer school from the class rank calculation or inform people that if they want to be on the top, the only way to do so is to take 4 years of summer school.” - Student Survey Response
- ❑ Learning vs competition
 - “Current system is out of student control and is based on what everyone else is doing.” - Shared by a parent to a principal
- ❑ Transfer students
 - “My graduate was at a disadvantage due to moving into the district from another state. (4.0 GPA, not in top 10%, 30 on ACT)” - Parent Survey Response

RESEARCH FINDINGS

- ❑ Admissions
 - Colleges and universities range in use of class rank - some not at all (UNL, Wayne, Doane, Wesleyan) to others using it as one of two to three performance criteria (UNO, UNK) or others who create own calculations (Creighton, NWMissouri)
 - Yale, Harvard, Stanford - Holistic evaluation of applicant
- ❑ Scholarship
 - UNO: Use a combination of ACT and either Class Rank or Cumulative Grade Point Average
 - UNL: Review overall academic profile, including Grade Point Average, ACT/SAT scores Class Rank (if provided) and rigor of coursework
 - Yale, Harvard, Stanford - Holistic criteria, special interest funded
- ❑ Practices of other districts

HIGHLIGHTS FROM RESEARCH ARTICLES

- ❑ “Research suggests that of all factors used in college admission decisions, grade point average and high school grades are the best predictors of college success.” - Hanover Research, November 2014
- ❑ “The practice of using class rank as a metric in admissions decisions has declined over the past two decades.” - Hanover Research, November 2014
- ❑ “Only 19% of colleges and universities give class rank “considerable importance” in the application process. Among the traditional measures of student quality, class rank is widely described by admissions officers as the fuzziest.” - Eric Hoover, *Chronicle of Higher Education*, December 2012
- ❑ “Grades in college preparatory courses and strength of curriculum were considered by colleges to be the top factors in the admission decision, followed closely by admission test scores and grades in all courses.” - Clinedinst & Hawkins, *State of College Admissions*, 2012

BENEFITS OF NEW SYSTEM: LATIN HONORS RECOGNITION

- Measures the performance based on the individual student and not against the performance of other students.
- Recognizes all students whose performance exceeds high academic standards.
- Utilizes a system familiar to and applied by most colleges and universities.
- Eases transfer of students between high schools within Millard without penalty due to the varied schedules.
- Allows students to not seek participation in summer school if only to focus on the mathematical advantage for class rank purposes.
- Enables students to focus on challenging themselves academically, focusing on areas of personal interest, and lessening anxiety if feeling pressured academically.
- Facilitates the potential that the three high schools could recognize students with the same honor code system during commencement.
