A meeting of the Board of Education of the School District No. 17, in the County of Douglas in the State of Nebraska was convened in open and public session at 6:00 p.m., Monday, August 17, 2015, at the Don Stroh Administration Center, 5606 South 147th Street.

Notice of this meeting was given in advance thereof by publication in the Daily Record on Friday, August 14, 2015; a copy of the publication is being attached to these minutes. Notice of this meeting was given to all members of the Board of Education and a copy of their Acknowledgment of Receipt of Notice and the agenda are attached to these minutes. Availability of the agenda was communicated in advance notice and in the notice of the Board of Education of this meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

President, Pat Ricketts, announced that the open meeting laws are posted and available for public inspection. Mr. Ricketts asked everyone to join in the Pledge of Allegiance.

Roll call was taken: Mr. Pate, Mr. Anderson, Mr. Ricketts, Mr. Kennedy and Mr. Meyer were present.

Mike Kennedy made a motion to excuse Linda Poole from the meeting, seconded by Paul Meyer. Voting in favor of said motion was: Mr. Anderson, Mr. Ricketts, Mr. Kennedy, Mr. Meyer and Mr. Pate. Voting against were: None. Motion carried.

Pat Ricketts announced the proper time for public questions and comments on agenda items only. There were no questions or comments.

Motion was made by Mike Kennedy, seconded by Dave Anderson, to approve the Board of Education Minutes from July 6, 2015, approve the bills and receive the treasurer's report and place on file. Voting in favor of said motion was: Mr. Meyer, Mr. Pate, Mr. Anderson, Mr. Ricketts and Mr. Kennedy. Voting against were: None. Motion carried.

Pat Ricketts summarized the Committee of the Whole meeting which was held on August 10, 2015.

Superintendent's Comments to the Board:

- We had a great start to the new school year with lots going on to celebrate the new school year.
- On August 7th we had a cook out for the custodial, maintenance and grounds staff. A couple of you were able to stop by and we appreciated that.
- During the fall workshop, staff development at the elementary level focused on digital learning. Kudos to those in Educational Services and Staff Development who pulled off some very exceptional training. When visiting classrooms last week, it was great to see the training being operationalized.
- Please be sure to check the Millard App and Twitter accounts. This is a great way to communicate with you and the public on the happenings in the District.
- This Friday, Jim will be part of the interview team for the Executive Director of the Learning Community.

Board Comments:

Paul Meyer: Mr. Meyer said his name was mentioned in the paper this weekend concerning a law, Neb. Rev. Stat. 79-8, 108, that requires all Nebraska public school teachers and other employees paid from public school funds, to sign a pledge. Mr. Meyer said this issue recently came up in the Hastings school and wanted to give the Board a heads-up that it may resurface in Millard.

Mike Kennedy: Mr. Kennedy thanked the teachers for a great start to the new school year. There are several new programs underway, which is exciting. He had a chance to read Dr. Sutfin's blog and was impressed with that. Mr. Kennedy wished everyone a great year.

Dave Anderson: Mr. Anderson attended the NASB Board meeting last weekend in Lincoln. Discussion was centered around the association's strategic plan for the next three to five years. Mr. Anderson stated he will roll off as an NASB Board member at the State Conference in November. Millard always has one permanent position on the Board so this position will open up. Dave also welcomed everyone back for a new school year.

Mike Pate: The Learning Community has met a few times since the last Board meeting. The issue at hand at these meetings has been to find a replacement for Ted Stilwell who is retiring from his position as CEO of the Learning Community. The search firm had only eight candidates apply and those applicants have been narrowed down to two. The committee, for which Mr. Pate is a part of, will interview these candidates on Friday. Mr. Pate gave a brief overview of these two candidates, where they are from, education, past jobs etc. Mike said that the Learning Community passed a levy increase from two funds, one of which is to fund the Early Childhood Initiative for which Millard will be a recipient at two sites.

Pat Ricketts: Mr. Ricketts also welcomed everyone back to school.

New Business:

Mike Kennedy provided the First Reading of Policy 4156 – Human Resources – Copyright Compliance.

Motion by Dave Anderson and seconded by Mike Pate to approve Rule 6315.1 – Curriculum, Instruction, and Assessment – Millard Education Program: Use of Assessment Data. Voting in favor of said motion was: Mr. Kennedy, Mr. Meyer, Mr. Pate, Mr. Anderson, and Mr. Ricketts. Voting against was: None. Motion carried.

Motion by Dave Anderson and seconded by Paul Meyer to approve Rule 6330.1 – Curriculum, Instruction, and Assessment – Grading Guidelines for Second-Twelfth Grade. *Mark Feldhausen explained to the Board that the new method to be used is the Latin system, which is recognition of students with a GPA of 3.5 and higher. Students with a GPA of 3.5 to 3.74 will be recognized as cum laude. Those earning a GPA of 3.75 to 3.99 will graduate magna cum laude and students with a GPA of 4.0 or better will be honored as summa cum laude. Dr. Feldhausen stated that this is a classification process, not a ranking process. The Latin System will begin with eighth graders this year as they plan for registration next school year.* Voting in favor of said motion was: Mr. Ricketts, Mr. Kennedy, Mr. Meyer, Mr. Pate and Mr. Anderson. Voting against was: None. Motion carried.

Motion by Dave Anderson and seconded by Mike Kennedy to approve the 2015-2016 Check 4 Learning Memorandum of Understanding. *Mr. Meyer asked how long this process has been around. Dr. Feldhausen responded that we have been engaged in this process for at least four years. In terms of Check 4 training, Dr. Feldhausen explained that we send a couple teachers as well as people out of the Assessment, Research, and Evaluation office. Dr. Feldhausen went on to explain that Check 4 emulates the structure of a NeSA exam and is a way for teachers to check on the progress their individual students are making. If students are not making adequate progress, teachers will go through re-teaching activities with these students to help them get back to where they need to be. Dr. Feldhausen stated this is a free service to us. We encourage teachers to use it as a preparation to achieve goals and monitor the learning process.* Voting in favor of said motion was: Mr. Pate, Mr. Anderson, Mr. Ricketts, Mr. Kennedy and Mr. Meyer. Voting against was: None. Motion carried.

Motion by Mike Kennedy and seconded by Dave Anderson that the Board approve the Learning Community Early Childhood/Bufett Institute Agreement and the Associate Superintendent for Educational Services be authorized and directed to execute all documents related to this program. *Mr. Meyer asked why we would start educating at birth to age three. Dr. Feldhausen explained that by Federal and State law, which went into effect in 1975, we are required to work with children who have disabilities at these ages. There are plans put together to assist parents in working with their children as well as to monitor the cognitive development of the students and to assist them in making sure their children are as prepared as can be for kindergarten and beyond. Dr. Feldhausen stated that the intent of this program is to provide a continuum of services and educational opportunity so that by third grade, we can look back and see how much progress the student has made and how beneficial the program was. Mr. Houlton reminded the Board that our program that works with children birth to three years is **only** focused on children with disabilities. He said there is overwhelming research indicating that catching students as early as possible, giving them services, and collaborating with the families effectively, shows these children grow up with fewer educational issues. Mr. Houlton also stated that the Bufett Initiative would take*

this a step further and target at-risk groups such as children born into poverty, children with low birth rates or multiple births who do not show signs of disabilities and set them up for a stronger start into education. Concerns were brought up of possibly draining our own resources. Dr. Feldhausen stated we are benefiting in multiple ways and does not see this as a drain on our resources but rather gaining additional resources. The Buffett Initiative funded \$302,000 for this program. If it is decided that that we would not continue this program, the existing programs would continue using funds from Early Childhood Special Education, Title I Funds (Federal money), Parent Pay resources as well as from the district at large. Voting in favor of said motion was: Mr. Pate, Mr. Anderson, Mr. Ricketts, and Mr. Kennedy. Voting against was: Mr. Meyer. Motion carried.

Motion by Mike Pate and seconded by Mike Kennedy that the Annual Cooperative Agreement for Dual Enrollment at the University of Nebraska at Omaha (UNO) and the Millard Public Schools, 2015-2016 be approved and that the Associate Superintendent for Educational services be authorized and directed to execute any and all documents related to this program. Voting in favor of said motion was: Mr. Anderson, Mr. Ricketts, Mr. Kennedy, Mr. Meyer and Mr. Pate. Voting against was: None. Motion carried.

Motion by Dave Anderson and seconded by Mike Kennedy to approve the Phase I & II proposal for the Disney Core Knowledge Academy and advance the project to Phase III and IV of Rule 10,001.1, subject to the Program Budgeting process. *Bethany-Case-Magana, Principal at Disney Elementary, was available to address questions and concerns from the Board. Parents and staff are very interested and are waiting for further information. The comments have all been positive. The intent is to have both Core and traditional classes at Disney. It has not been decided if Core will be started in kindergarten only for the first year and when that class rolls up to first grade, then another kindergarten Core class will be added. Another possibility would be to start the first year of Core with kindergarten, first and second grades and when these grades roll up the next year, new classes of Core will again be added at the kindergarten, first and second grades. Principal Case-Magana was commended by the Board and Dr. Feldhausen, Director of Educational Services, for embracing this new challenge at her school. Voting in favor of said motion was: Mr. Kennedy, Mr. Meyer, Mr. Pate, Mr. Anderson, and Mr. Ricketts. Voting against was: None. Motion carried.*

Motion by Dave Anderson and seconded by Mike Pate to that the approval be given to the Resolution for Participation in Papio-Missouri River NRD Multi-Hazard Mitigation Plan as submitted. *Mr. Fossen commented that this resolution is coming before us now in case we would ever need to apply for FEMA grants or reimbursement for expenses through FEMA. He said we have to belong to an organization that has a hazard mitigation plan or we would need to develop one individually. Voting in favor of said motion was: Mr. Ricketts, Mr. Kennedy, Mr. Meyer, Mr. Pate and Mr. Anderson. Voting against was: None. Motion carried.*

Mr. Ricketts requested that Executive Session be moved to the end of the reports.

Reports:

Enrollment Report – 3rd Day Count: Dr. Feldhausen reminded everyone that the 3rd day count is only those students that are present in school on that day. We do not count those students that are declared absent for the day. In looking at the numbers, they are very similar to those in the past few years. There was further discussion as we look to the future regarding student numbers and class sections at various schools.

Leadership and Learning Department Annual Staff Development Report: Dr. Heather Phipps stated that this report summarizes the staff development over the last year for our teachers and hourly staff members. Mr. Pate asked if our information is shared with other districts to which Dr. Phipps said it is shared. Mr. Pate complimented the Leadership and Learning Department on doing a great job and stated he felt we have the best in the area. Mr. Meyer asked that with so many meetings planned, do all staff attend every meeting. Dr. Phipps responded by saying not every teacher is taking everything we have to offer. When planning, we try to offer classes to catch the interests of many different people.

Construction Report (Rockwell): Ed Rockwell gave an update of where the projects are at right now. He stated that they are on target. The wet weather this summer had slowed things down some, but other than that, all is well. Mr. Rockwell pointed out pictures of a school where new lighting had been added and compared it to a picture of a school that still has the old lighting. There was a significant difference. Eventually, all schools will have the new lighting.

Construction Report (Sampson): Dave Cavlovic with Sampson Construction was available to address questions and concerns from the Board. He stated that there were ten projects under management by Sampson this summer of which nine have been completed. The last one is MNHS which will be completed next summer. Over a four year plan of projects, Sampson is approximately 50% finished. Mr. Ricketts asked how the traffic flow at MNHS went on the first day of school. Mr. Cavlovic said it was quite backed up, but got better as the week went on. A time extension was requested for the stop lights, which has helped with the traffic flow. Mr. Cavlovic said that this fall, schematic designs will be brought to the Board for approval for MWHS, Neihardt Elementary and Upchurch Elementary. These projects will lead off the work to be done this next year.

Field trips shall be considered as instruction and planned as such with definite objectives determined in advance. Lists of curriculum-related field trips shall be made available by the offices of elementary and secondary education.

- I. Appropriate instruction shall precede and follow each field trip.
- II. All school rules and the District's Standards for Student Conduct shall be in effect.
- III. Written approval of the parent or guardian is required for participation of students in field trips.
- IV. At the elementary and middle school levels, all field trips shall begin and end at the school unless approved and communicated by the principal.

- IX. When a field trip is made to a place of business or industry, it shall be required that an employee of the host company serve as conductor.

Taught Curriculum - Purchase and Loan of Textbooks to Private School Students

6295.1

The Associate Superintendent for Educational Services will be responsible for purchasing textbooks from funds made available by the Nebraska Department of Education and for lending those textbooks to students attending approved or accredited private schools in accordance with state statutes and regulations promulgated by the Nebraska Department of Education.

- I. On or before November 15, a list of textbooks designated for ~~current~~ use in the Millard Public Schools during the current school year and a list of the textbooks designated for use in the school districts where the private schools are located will be made available. This list shall also include any new textbooks that the school district has determined by November 15 to be used during the next school year. If, after November 15 but before January 15, the school district makes the decision to acquire new texts, the district will notify the non-public school parents that the textbook list has been amended and that the added books are eligible for requisition. Textbook shall mean a book and/or electronic media, which is designated, for use in classroom instruction as the principle source of study material. Library books, teacher's editions, workbooks and other similar materials are not to be considered textbooks.
- II. A copy of the list shall be made available for inspection at the Don Stroh Administration Center in the office of Educational Services. Reproduction of the list may be provided upon request for a reasonable fee. The school district shall limit the loan each year to ten textbooks per student for students in grade K-6 and to eight textbooks per student for students in grades 7-12.
- III. Application by a parent or legal guardian for the loan of textbooks shall be made to the school district in which the child resides or the school district in which the private school the child attends is located no later than January 15 for the following school year on behalf of each individual child on designated NDE form. Application forms are available in the Office of Educational Services at the Don Stroh Administration Center and on the Nebraska Department of Education website.
- IV. Prior to February 15 of each year, the district will file an application with the Nebraska Department of Education on the designated NDE form requesting funding for the requested books.
- V. Textbooks for which application has been made will be purchased from the funds made available by the Nebraska Department of Education. The following course and grade priorities are established to select textbooks that will be purchased if, after the distribution of funds, the school district will be unable to purchase all of the textbooks for which applications have been made due to a prorata reduction in the funds by the Nebraska Department of Education.

1	Elementary Reading texts by grade 1-5

If it is necessary to use grade level to establish priorities to select the textbooks that will be purchased and loaned, students in the lowest grade level will receive the highest priority. In the event that there are not

enough textbooks for a particular subject and grade level to fill all of the individual requests, textbooks will be distributed on the basis of a random drawing.

- VI. Parents or guardians receiving textbooks shall be notified in writing at least ten (10) days prior to the beginning of public school classes outlining the procedures and dates for distribution and return of textbooks. In private schools dealing with large numbers of parents and students, there can be a multi-family designation of a parent representative via "power of attorney" to pick up and return the texts prior to and after the school year.
- VII. The parent or legal guardian of each private school student receiving a textbook (textbooks), or the parent representative serving via the "power of attorney", shall pick up the books at a place and time designated by the Millard Public Schools and sign a receipt for said text(s). The designated NDE form shall be used. A separate inventory of textbooks available for loan shall be maintained by the Office of Educational Services.
- VIII. A parent or legal guardian of each private school student, or the parent representative serving via the "power of attorney", shall return textbooks to the Distribution Center on or within 15 days after the last day of public school classes. Such inventory may be maintained at a facility of the school district which purchased the textbooks or at an alternative site or sites agreed upon by the school district and the authorized parent representative(s) responsible for such textbooks. If an alternative inventory site is designated, the authorized parent representative(s) shall be deemed to have custody of such textbooks, be personally liable for the safekeeping of such textbooks, and shall maintain a documented inventory-control system as agreed upon with the school district.
- IX. It shall be the responsibility of the parent or legal guardian to reimburse the school district for the replacement value of any damaged or lost loaned textbooks. The unit cost at the time of purchase shall be the basis for the assessment. A new book is assessed at net cost. The amount to be charged decreases each year by one-fourth of the net cost of the book until one-fourth of the net cost is reached. This is the minimum amount, which may be charged students for a lost or damaged book.
- X. Parents or legal guardians who have failed to reimburse the school district for lost or damaged textbooks will not be loaned textbooks in the future until such reimbursement has been made. Amounts recovered from parents or students for damaged textbooks or textbooks not returned shall be retained in a separate account and used to offset the amount claimed in future years for distribution.
- XI. Textbooks purchased with these funds shall be made available to private school children so long as the textbooks remain on the list, and are not lost, stolen, destroyed or damaged beyond repair.

Extracurricular school-sponsored clubs and activities, and interscholastic athletics and activities are an extension of the selected content curriculum and instructional strategies of the Millard Education Program, whether or not they occur in a traditional classroom setting. As an extension of the Millard Education Program, and as a result of financial, facility, personnel, and interest limitations and constraints, the number and nature of extracurricular school sponsored clubs and activities, and the number of interscholastic athletics and activities will be restricted to those which meet the criteria of and which are approved according to the procedures specified in District Rules 6700.1 and 6700.2. The District shall not be required to approve or promote any extracurricular school sponsored clubs and activities, or any interscholastic athletics and activities which are suggested for approval. Extracurricular school-sponsored clubs and activities, and interscholastic athletics and activities are separate and distinct from the co-curricular activities such as band and choir, in which students must participate as part of the requirements for enrollment in and receiving a grade for a particular course. Extracurricular school-sponsored clubs and activities, and interscholastic athletics and activities are separate and distinct from the student-initiated, non-curriculum related secondary school student groups which are permitted to conduct non-curriculum related student group meetings on the premises of secondary schools, pursuant to the equal access provisions of federal law and District Policy 5520 and Rule 5520.1. Such non-curriculum related secondary school student groups are not extracurricular, are not school-sponsored, are not an extension of the Millard Education Program, and are not governed by this Policy or District Rules 6700.1 through 6700.8.

6700.1

I. Extracurricular School-Sponsored Clubs and Activities

Extracurricular school-sponsored clubs and activities are an extension of the selected content curriculum and instructional strategies of the Millard Education Program. Extracurricular school-sponsored clubs and activities serve as an extension of the Millard Education Program by providing and promoting opportunities, activities, experiences, and/or programs which supplement the subject matter of specific courses, extend the skills taught in specific courses, reinforce the instruction provided in specific courses, provide career activities and exploration, recognize and promote academic achievement and excellence, provide intramural athletic competition, enhance school support and spirit, or provide for the administration of student government or student body activities.

II. Approval Procedures and Criteria

- A. Certain extracurricular school-sponsored clubs and activities are established and recognized as being school-sponsored and an extension of the Millard Education Program and they shall not be required to obtain approval, except for funding, when properly operating under this Rule. These established and recognized extracurricular school-sponsored clubs and activities include:

- B. All other presently existing and all other suggested future extracurricular school-sponsored clubs and activities shall be required to seek and obtain approval in accordance with the following procedures and criteria.
1. A suggestion form from the District Activities Committee shall be properly and fully completed by the school certificated staff member who suggests the formation of the extracurricular school-sponsored club or activity and who proposes and is qualified to serve as the certificated staff sponsor. Such suggestion forms will be submitted by certificated staff employed by the District only.
 2. Such suggestion forms shall be submitted to the school principal or designee. All suggestion forms which are not properly and fully completed shall not be considered.
 3. The principal or designee shall review the suggestion form and such other information considered to be appropriate and make a written recommendation whether or not to form such a school-sponsored club or activity based on the criteria set forth hereinafter. If the suggestion is accepted by the building principal or designee, the suggestion form will be forwarded with [a written](#) recommendation to the District Activities Committee within forty (40) school days after receipt of the suggestion form.
 4. Within eighty (80) school days after receipt of the suggestion form and [written](#) recommendation, the [District](#) Activities Committee shall meet, review the suggestion form and recommendation of the principal or designee and such other information considered to be appropriate, and make a written decision to approve or deny the formation of such a school-sponsored club or activity based on the criteria set forth below.
 5. When reviewing any suggestion to form a new extracurricular school-sponsored club or activity, the principal or designee and the [District](#) Activities Committee shall evaluate the following considerations and criteria. Whether the suggested school-sponsored club or activity:
 - a. Provides and promotes opportunities, activities, experiences, and/or programs which supplement the subject matter of specific courses, extend the skills taught in specific courses, or reinforce the instruction provided in specific courses.

- b. Provides and promotes opportunities, activities, experiences, and/or programs which involve career activities or career exploration.
- c. Provides and promotes opportunities, activities, experiences, and/or programs which involve career preparation and technical education, such as business education, career guidance and counseling, family and consumer sciences, industrial education, marketing education, health occupations education, or diversified occupations education.
- d. Recognizes and promotes academic achievement and excellence.
- e. Provides problem-solving skills or higher level thinking skills through club competition or club exercises.
- f. Provides hands-on experiences which extend the learning process beyond the classroom or provides opportunities to practice and apply the curriculum or skills taught in specific courses.
- g. Provides and promotes opportunities, activities, experiences, and/or programs which involve intramural athletic competition, team leadership and cooperation, sportsmanship, sports and recreation skills, physical development, or physical education.
- h. Provides and promotes opportunities, activities, experiences, and/or programs which enhance school support and spirit through organized cheering, support the school's interscholastic athletics and activities programs, or build student morale, student spirit, or positive support for the school and the school's interscholastic programs.
- i. Provides for the administration of student government or student body or class activities and programs.
- j. Provides for and promotes middle school level exploration of activities, socialization, or citizenship.
- k. Shows evidence of strong student interest and has potential for growth and longevity.
- l. Has adequate funding. Funding should not be diverted from existing school-sponsored clubs or activities so as to create new ones.

- m. Has adequate facilities available.
 - n. Has qualified and competent sponsors available, who are District certificated staff, or selected community volunteers, or paid volunteers.
 - o. Duplicates the general purposes of an existing sponsored club or activity, an existing equal access student group, or existing activities or programs which are already available within the District or within the community.
 - p. Is appropriate for the knowledge level, intellectual maturity, competence, and age of the students.
 - q. Involves exposure to or risks of injury or harm.
 - r. Can operate in compliance with federal and state laws and the policies and rules of the District.
 - s. Is an appropriate addition to the number and nature of clubs or activities at a school.
- 6. No extracurricular school-sponsored clubs or activities shall involve or promote the indoctrination or advocacy of partisan, political, ideological, or religious beliefs.
 - 7. No extracurricular school-sponsored clubs or activities shall be a secret fraternity or secret organization.

III. **Student Participation**

- A. Participation of students in extracurricular school-sponsored clubs and activities is encouraged, and participation shall be open to and limited to all students who are currently enrolled in the sponsoring school on a voluntary basis as well as Exempt School Students and Nonpublic School Students pursuant to District Rules 6675.1 and 6680.1. Extracurricular school-sponsored clubs and activities may establish academic or course enrollment qualifications for participation if such qualifications are necessarily related to the purposes of that extracurricular school-sponsored club or activity.
- B. Students will be limited in participating in activities of a non-school nature during school hours. Prior to such participation, approval must be granted by the building administrator.

IV. Governance

All extracurricular school-sponsored clubs and activities shall be under the exclusive governance and control of school personnel. Such exclusive governance and control shall include, but shall not be limited to, the formation, naming, structure, operation, financing, and discontinuance of all extracurricular school-sponsored clubs and activities. Extracurricular school-sponsored clubs and activities shall not have any separate or individual existence, status, rights, or authority.

V. Sponsors

- A. Each extracurricular school-sponsored club and activity must have a sponsor who is a District certificated staff member, or selected community volunteer or paid volunteer, who is qualified by virtue of education, training, experience, or special interest to serve as the sponsor. The principal or designee shall select the sponsor. [The](#) District certificated staff member who submits a suggestion form may or may not be selected as the sponsor.
- B. Sponsors shall be required to: develop materials, activities, and a budget; promote membership and participation; communicate with the principal or designee, staff, students, and parents; schedule meeting dates and locations; plan meaningful experiences; supervise students during activities; evaluate and make recommendations; and submit a year-end report to the principal or designee.
- C. An assignment as a sponsor is an annual appointment. One (1) activity stipend may be issued to a District certificated staff member for extracurricular school-sponsored clubs or activities, in accordance with budgeting procedures, that have between ten (10) and forty-five (45) active participants. When unanticipated participation exceeds forty-five (45) active participants, an additional activity stipend may be issued for an additional sponsor for the current school year only upon approval by the Superintendent or designee. Any such additional stipends will terminate at the end of the current school year. Under certain circumstances which sometimes exist with different types of extracurricular school-sponsored clubs or activities, the individual schools may be excluded from these number restrictions with the approval of the Superintendent or designee. With the approval of the principal or designee, two (2) or more District certificated staff members may be allowed to split an activity stipend for an extracurricular school-sponsored club or activity.

VI. Review and Revocation

- A. The principal or designee shall review the activities and purposes of extracurricular school-sponsored clubs and activities on a regular basis and the principal or designee may, on their own initiative or upon any complaint or request by students, certificated staff, or parents, recommend to the [District](#) Activities Committee that

recognition of any extracurricular school sponsored club or activity be revoked. Recommendations for revocation shall be forwarded to and processed by the [District](#) Activities Committee in the manner provided above for applications.

- B. The [District](#) Activities Committee may on its own initiative, review and revoke the recognition of any extracurricular school-sponsored club or activity.

Interscholastic Athletics and Activities - Approval Procedures and Criteria

6700.2

I. Interscholastic Athletics and Activities

Interscholastic athletics and activities programs shall be established for both sexes and all such programs shall be sanctioned by and be in compliance with the rules and regulations of the Nebraska School Activities Association, the National Federation of State High School Associations, and the policies and rules of the District.

II. Student Participation and Eligibility

- A. In compliance with the rules established by the Nebraska School Activities Association, the principal or designee has the responsibility for determining the eligibility of students.
- B. It shall be the responsibility of the coach to determine which candidates shall be members of the team.
- C. Standards for participation, conduct, and personal appearances shall be established by the coaches and such standards shall be reasonable and in harmony with the philosophy and goals established by the District. In the case of any dispute, the principal or designee shall be responsible for resolving the issue.
- D. All participating students shall meet the rules and regulations established by the Nebraska School Activities Association, the National Federation of State High School Associations, and the District.

III. Approval Procedures and Criteria for New Interscholastic Sports and Activities

- A. All interscholastic sports and activities shall be required to obtain approval for adoption in the District in accordance with the following procedures and criteria.
 - 1. An Interscholastic Sports and Activities application form shall be completed by the school principal or designee and submitted to the District Activities Committee.
 - 2. When reviewing the application for an interscholastic sport or activity, the District Activities Committee and the Board of Education shall evaluate the following considerations and criteria. Whether the interscholastic sport or activity:
 - a. Can be conducted in compliance with the rules and regulations of the Nebraska [School Activities Association and the](#) District.

- b. Will meet a strong student interest which is not being met by the District or other community sports or activity programs.
 - c. Is appropriate for the knowledge level, intellectual maturity, competence, and age of the students.
 - d. Has potential for growth.
 - e. Will equalize the opportunities for girls and boys and meet the intent of Title IX.
 - f. Provides adequate opportunity for participation and competition.
 - g. Duplicates the general purposes of an existing interscholastic sport ~~of interscholastic sport~~ or activity offered by the District or other community sports or activities offerings.
- ~~and, whether:~~
- h. Given the number and nature of interscholastic sports and activities in the District and community, it is appropriate to add the interscholastic sport or activity.
 - i. The season in which the interscholastic sport or activity would be held allows for adequate participation and competition, given the weather and geographical conditions.
 - j. Adequate facilities are available for the interscholastic sports or. Adding a newly sanctioned interscholastic sport or activity should not overburden existing facilities.
 - k. Adequate funding is available for the newly sanctioned interscholastic sanctioned interscholastic sport or activity. Funding should not be should not be diverted from existing interscholastic sports or activities to create new ones. All funding requirements, including start up and annual operation costs, must be considered.
 - l. Qualified and competent coaches and staff are available.

IV. Coaches

- A. All interscholastic sports and activities must have a coach or sponsor who is a District certificated staff member or selected community member who meets District and Nebraska School Activities Association requirements.
- B. An assignment as a coach or sponsor of interscholastic sports and activities is an annual appointment. One (1) activity stipend may be issued to a District certificated staff member or selected community member who meets District and Nebraska School Activities Association requirements for interscholastic sports and activities, in accordance with budgeting procedures. When unanticipated participation occurs, as determined by the Superintendent or designee upon request from a school, an additional interscholastic activity stipend per season may be issued for an additional coach or sponsor for the current school year only upon approval by the Superintendent or designee. The funds used for this additional interscholastic activity stipend must come from budgets already allotted to the school by the District and cannot come from other funds or resources of the school. Any such additional stipends will terminate at the end of the current school year. With the approval of the principal or designee, two (2) or more District certificated staff members may be allowed to split an activity stipend for an interscholastic athletic program or extracurricular activity.

V. Review and Discontinuance

- A. The District Activities Committee shall regularly review the activities and purposes of interscholastic sports and activities and the District Activities Committee may recommend to the Board of Education that any interscholastic sport or activity be discontinued. Recommendations for discontinuance shall be forwarded to and processed by the Board of Education in the manner provided above for interscholastic sports or activities.
- B. The Board of Education may on its own initiative, review and discontinue any interscholastic sport or activity.

 - A. The coach or ~~club or activity~~ sponsor and principal or designee will ensure that the hourly driving limitations of Title 92, Nebraska Administrative Code, Chapter 91-005. 07G are communicated to the provider of transportation prior to the start of the trip.
 - B. The coach or ~~club or activity~~ sponsor will ensure that the provider of transportation provides a written plan to the principal or designee prior to the start of the trip that adheres to the hourly driving limitations of Title 92, Nebraska Administrative Code, Chapter 91-005. 07G.
 - C. The time of departure for the trip shall be no earlier than 6:00 a.m. on the starting day of the trip. Exceptions to this time of departure must have the prior approval of the District Director of Activities.
 - D. When the anticipated time of departure for the trip is earlier than 6:00 a.m. on the day of the event, the trip shall be subject to the following guidelines:
 1. The time of departure must have the prior approval of the District Director of Activities, or
 2. The coach or ~~club or activity~~ sponsor must arrange for the overnight accommodations of the students, drivers, chaperones, and coaches or ~~club or activity~~ sponsors involved on the trip for the night prior to the event, and
 3. The overnight accommodations must be reserved prior to the start of the trip and will follow the overnight travel and trip guidelines.
 - E. The time of arrival on the return date of the trip shall be no later than 12:~~00 a.m.~~ ~~midnight~~ on the day of the event. When the anticipated time of arrival on the return date of the trip is later than 12:~~00 a.m.~~ ~~midnight~~, that time must have the prior approval of the District Director of Activities.

F. When the anticipated time of arrival for the trip is later than 12:00 a.m. ~~midnight~~ on the day of the event, the trip shall be subject to the following guidelines:

1. The coach or ~~club or activity~~ sponsor will arrange for the overnight accommodations of the students, drivers, chaperones, and coaches or ~~club or activity~~ sponsors involved on the trip for the concluding night of the event. Those involved on the trip will return to the school on the next day, and
2. The overnight accommodations must be reserved prior to the start of the trip, and
3. The coach or ~~club or activity~~ sponsor will follow the overnight travel and trip policies and rules, or
4. Upon the arrival to the school the students involved on the trip shall leave the school by means other than walking. A certificated staff member of the school will remain in a designated area at the school with the students involved on the trip until all of those students have left the school.
 - a. The designated area at the school is subject to ~~the~~ approval by the principal or designee.
 - b. The designated area at the school will be communicated to the parents/guardians of the students involved on the trip prior to the trip.
 - c. Students on the trip are to remain in the designated area of the school until they are released by the certificated staff member.
 - d. The name(s) of ~~the~~ any person(s) other than the parents/guardians of the students involved on the trip who will retrieve the student(s) after arrival to the school must be provided to the coaches or ~~club or activity~~ sponsors prior to the trip.
 - e. The person(s) retrieving the students on the trip must come to the designated area at the school for the trip to retrieve the students.

G. Any exceptions to these guidelines must have the prior approval of the District Director of Activities.

VI. The coach or ~~club or activity~~ sponsor, in consultation with the principal or designee, may give a student permission to use alternate transportation.

District Cohort Graduation/Drop-Out Rate

Table 3 represents enrollment and graduation data reported to the Nebraska Department of Education (NDE) and available in NDE's Graduation Cohort Analysis Tool as of August 23, 2015. A graduation cohort is defined by the year a student first enrolled in 9th grade; students in the 2015 graduation cohort entered 9th grade in the 2010-2011 school year. Students who moved out of the district after starting 9th grade in Millard in 2010-2011 were removed from the cohort; students coming in to the district after starting 9th grade in another district in 2010-2011 were added to the cohort. Cohort graduation rates are calculated by dividing the number of graduates by the number of students in the cohort. Enrollment and graduation data are reported to NDE by their responsible or "home" school, thus students at Horizon, the Young Adult Program, or at external placements are reflected in the counts of their home schools.

Open Enrolled Students

The open enrollment program was implemented prior to the 2010/2011 school year. Open enrollment allows students within Douglas and Sarpy counties to enroll into other districts located within the Learning Community if space is available within the district schools. Siblings are given first priority followed by those who increase economic diversity. If more applications are received than space is available, a “randomization” is used to determine acceptance. Option enrollment remains in effect for students living outside the Learning Community.

For the 2014-15 school year, the following Millard schools were closed to Open and Option Enrollment students: Black Elk Elementary, Reagan Elementary, Reeder Elementary, Rohwer Elementary, Upchurch Elementary, Wheeler Elementary, Beadle Middle School, Russell Middle School, Millard West High School.

STUDENT DISCIPLINE

The goal and intention of the District is to enable students to obtain an education within a safe environment, free of violence or the threat of violence, illegal drugs, alcohol, weapons, or any conduct which interferes or disrupts the educational process.

Each school year an emphasis is placed on consistent reporting. To help ensure that data is reported consistently, monthly student discipline meetings are held with building principals and assistant principals. An alphabetical listing of “events” complete with detailed definitions was created in 2008 and was annually shared with each building administrator. This “event” listing is reviewed annually by the discipline committee and can also be found in the student management system, Infinite Campus. Each time a behavior is entered into Infinite Campus, the list can be easily accessed electronically to ensure the correct “event(s)” is/are being entered into the system.

Student Code of Conduct

The Standards for Student Conduct (Rule 5400.6) is a document that defines the disciplinary rules for the Millard School District. These rules are uniform across the District and are approved by the Board of Education each school year. The Standards for Student Conduct are published in the student handbook by each building and are reviewed with students annually. All students are required to sign a receipt that they have received and understand the Standards for Student Conduct.

The Standards for Student Conduct define each behavior that is a violation of the District Policy, Rules, Procedure as well as state and federal law. Such rule violations are called “events”. For each “event” the Standards for Student Conduct lists a sanction that defines the parameters administrators can use to respond to the student’s violation. The Nebraska Department of Education requires schools to report specific “events”. For this reason and to create more consistent reporting, the “event” and “resolution” codes found in this report reflect the requirements of the Nebraska Department of Education.

Drug and Violence Event Summary

School/Community Intervention Program (SCIP) Team Activities

Each secondary school has an active SCIP team to assist students with potential drug/alcohol problems. Teachers are encouraged to refer students to their school's SCIP Team if they suspect a drug/alcohol-related problem.

Teams collect additional information on referred students to determine if there is a reason to believe a student might have a concern relating to drug/alcohol dependency issues. Other referrals come from parents or from the hotline which alerts SCIP leaders to potential drug or alcohol problems. If it is determined that there is a potential problem, parents/guardians are contacted and encouraged to have their child take a drug/alcohol evaluation, get treatment, or take other steps to solve the problem.

Alcohol-Possession/Alcohol-Use of or Under the Influence. Possession of Alcohol or Other Drugs. Possession or use of an illegal narcotic drug, controlled substance, mood-altering or behavior-affecting substance, or look-a-like substance, or possession or use of a prescribed medication by a student for whom the prescribed medication was not prescribed; or possession or use of drug paraphernalia. Possession or use of alcohol-containing beverage or liquor capable of human consumption.

"Possession of a substance" shall mean situations where a student has on his person, within his personal property, within school property assigned to him or under his control, a substance prohibited under this Rule, while on school property or at a school sponsored or school-related activity. (This does not include Off Campus violations).

Arson of False Alarm. Intentionally starting a fire. Use of any fire causing agents to start or attempt to start a fire. Purposely or knowingly causing a false alarm. Neb. Rev. Stat. §§28-502 to 504 and 907; Neb. Rev. Stat. §79-267(9).

Bomb Threat. Threatening to use any type of explosive or incendiary device generally referred to as a bomb to injure a person(s) or destroy property.

Purposely making a false alarm or false report, or purposely furnishing false information or making a false communication or statement, weather verbal, written or electronic, concerning the existence of any bomb, explosive device or weapon, dangerous chemical substance, or biochemical or terroristic device, or concerning another's intent or attempt to be made to kill, injure, or intimidate any individual or to use any bomb, explosive device, or weapon, dangerous chemical substance, or biochemical or terroristic device, or concerning the need for medical, police, or emergency services or procedures. Neb. Rev. Stat. §§28-907 and 1221; Neb. Rev. Stat. §79-267(9).

Bullying. Bullying means any intentionally hostile or offensive verbal, written, graphic, demonstrative, electronic, or physical act that has the purpose of exerting domination over another student through the act of intimidating, frightening, oppressing, or adversely controlling the student, and that is disruptive of the educational process, or any ongoing pattern of physical, verbal, written, graphic, demonstrative, or electronic abuse, on school grounds, in a vehicle owned, leased, or contracted by a school being used for a school purpose by a school employee or his or her designee, or at school-sponsored activities or school sponsored athletic events. This may include, but is not limited to, verbal, graphic, written, or electronic activities such as name-calling, taunting, blackmailing, inciting to fight, terrorizing, or physical or demonstrative activities such as poking, blocking or impeding, following, hair pulling, mock hitting motions, intentionally bumping, tripping, and damaging clothing. Neb. Rev. Stat. §79-267(8).

Cheating or Plagiarism. Cheating on examinations including but not limited to ELO examinations. Plagiarism on projects including but not limited to reports, research papers, and portfolios.

Computers. Direct or indirect use of district computers, computer networks, or computer systems, which involves offensive, personal, commercial or any unauthorized access or use of a district computer, computer network, or computer system which violates district policy or state or federal law. Neb. Rev. Stat. §28-1341; Neb. Rev. Stat. §79-267(9).

Damage to Property. Willfully causing or attempting to cause substantial damage to property, or repeated damage to property. This shall include school property lent to the student which the student damages. As to any such damaged property, the student's parent(s) or guardian(s) shall be liable for the damage to the school property. Neb. Rev. Stat. §79-267(2).

Dishonesty. Dishonesty that interferes with the educational process.

Disparaging Language/Symbolism. Disparaging or demeaning language or symbolic actions of any kind including, but not limited to gestures or language that is intended to disparage, demean, or subject another student or staff member to ridicule.

Disruptive Behavior. Behavior or possession of any item that materially interferes with or substantially disrupts class work, school activities, or the educational process.

Distribution of Alcohol. The dispensing, sale, or the intent to sell or dispense an illegal narcotic drug, look-a-like substance, controlled substance, mood-altering or behavior-affecting substance, or alcoholic beverage, provided the student has received a citation by a law enforcement officer which involves the offense subject to this subsection or the student admits that he or she has violated the subsection.

Distribution of Drugs. The dispensing, sale, or the intent to sell or dispense an illegal narcotic drug, look-a-like substance, controlled substance, mood altering or behavior-affecting substance, or alcoholic beverage, provided the student has received a citation by a law enforcement officer which involves the offense subject to this subsection or the student admits that he or she has violated this subsection.

Distribution of Non-Prescribed Medications. Distribution or attempted distribution to any other person, of any non-prescribed medication.

Distribution of Prescribed Medications. Distribution or attempted distribution to any other person, of any prescribed medication.

Drugs-Possession Of. “Possession of a substance” shall mean situations where a student has on his person, within his personal property, within school property assigned to him under his control, a substance prohibited under this Rule, while on school property or a school sponsored or school related activity. (This does not include Off Campus violations).

Possession of Alcohol or Other Drugs. Possession or use of an illegal narcotic drug, controlled substance, mood-altering or behavior-affecting substance, or look-a-like substance, or possession or use of a prescribed medication by a student for whom the prescribed medication was not prescribed; or possession or use of drug paraphernalia. Possession or use of alcohol or an alcohol-containing beverage or liquor capable of human consumption.

Drug-Use of or Under the Influence. Being intoxicated or under the influence of any illegal narcotic drug, controlled substance, prescribed medication by a student for whom the prescribed medication was not prescribed, mood-altering or behavior-affecting substance, or alcohol.

Exposure to Bodily Fluids. Intentionally spitting, throwing, wiping, or otherwise dispersing bodily fluids on or to another student or staff member for the purpose of infecting, inciting, demeaning, or intimidating that person.

Extortion. Threatening or intimidating any student for the purpose of or with the intent of obtaining money or anything of value from such student.

False Alarm or Report. Purposely making a false alarm or false report, or purposely furnishing false information or making a false communication or statement, whether verbal, written or electronic, concerning the existence of any bomb, explosive device or weapon, dangerous chemical substance, or biochemical or terroristic device, or concerning another’s intent or attempt to be made to kill, injure, or intimidate any individual or to use any bomb, explosive device or weapon, dangerous chemical substance, or biochemical or terroristic device, or concerning the need for medical, police, or emergency services or procedures. Neb. Rev. Stat. §§28-907 and 1221; Neb. Rev. Stat. §79-267(9).

False Complaints. False Accusations or complaints against another student or staff member.

Fighting. Mutual attempt to physically harm another person through mutual combative physical contact.

Gambling. Playing any game of chance for money or other stakes. Neb. Rev. Stat. §79-267(9).

Guns. Guns, etc. Knowingly possessing, handling, transmitting, using intimidating with, or threatening with any object or material that is ordinarily and/or generally considered a firearm, explosive, destructive device, or weapon, including, but not limited to, firearms, pipe bomb, and pellet/BB gun.

Harassment. Any intentionally hurtful, demeaning, or disparaging acts, words, symbolic representations, or behavior used by a student or students against another student or students that is disruptive of the educational process. This includes, but is not limited to, verbal, physical, visual, or graphic actions such as name-calling, taunting, mocking, slandering, humiliating, defaming, teasing, pestering; and making derogatory remarks, demeaning jokes, disparaging drawings or notes.

Hazing. Any activity by which a person intentionally or recklessly endangers the physical or mental health or safety of an individual for the purpose of initiation into, admission into, affiliation with, or continued membership with or participation in any group or activity. Such hazing activity shall include, but shall not be limited to the following: whipping; beating; branding; forced and prolonged calisthenics; prolonged exposure to the elements; forced consumption or any food, liquor, beverage, drug, or harmful substance not generally intended for human consumption; prolonged sleep deprivation; harassing by exacting unnecessary or disagreeable work, banter, ridicule, or criticism; or any brutal treatment or the performance of any unlawful act which endangers the physical or mental health or safety of any person. Consent to the hazing by the student(s) shall not be a defense to hazing.

Insubordination. Disrespect for, defying authority of, or refusing to obey requests or directions of teachers, school officials or school employees.

Larceny (Theft). Committing a burglary or theft that constitutes a felony, provided the student has received a citation by a law enforcement officer which involves the offense subject to this subsection or the student admits that he or she has violated this subsection.

Nuisance Item. Any item in a student's possession that is sufficiently annoying, offensive, unpleasant, or obnoxious that it substantially interferes with or materially interrupts the educational process. These items may include, but are not limited to radios, camera cell phones, beepers, walkie-talkies, tape players, cameras, devices that emit laser light beams, and other electronic devices.

Other Weapons. Using or threatening with a knife, throwing star, brass knuckles, chemical substances (including, but not limited to, mace, pepper guns, and bleach), and any other object that could be used to injure a person.

Physical Assault. Initiation of a violent act against another person through aggressive physical contact.

Physical Injury. Physical Injury to District Employees, Volunteers, and Students. Causing or attempting to cause personal injury to any district employee, school volunteer, or to any student, provided the student has received a citation by a law enforcement officer which involves the offense subject to this subsection or the student admits that he or she has violated this subsection.

Possession of Certain Prohibited Objects. Knowingly possessing, handling, or transmitting knives, throwing stars, brass knuckles, or other objects not enumerated above which could cause injury.

Possession of Fireworks. Possession shall mean situation where a student has on his person, within his personal property, within school property assigned to him or under his control, a substance that can be ignited to cause any form of expulsion prohibited under this Rule, while on school property or at a school sponsored or school-related activity.

Possession of Look-a-Like Weapon. Possessing a look-a-like weapon, the object must closely resemble a real weapon in size, shape, and color even when examined up close.

Possession of Medications (Preschool and Elementary Levels). Possession of prescribed or non-prescribed medication, or possession of prescribed or non-prescribed medications on school ground during transportation to and from school, is prohibited. Elementary school students may possess and use inhalers, as well as glucose tablets, according to the provisions of Rule 5600.2.

Possession of Medication (Middle School Level). Possession of prescribed or non-prescribed medications, or possession of prescribed medications on school grounds during transportation to and from school, is prohibited. Middle school students may transport non-prescribed medications to and from school but must turn it into the nurse upon arrival at school. Middle school students may possess and use inhalers, as well as glucose tablets, according to the provisions of Rule 5600.2.

Possession of Medications (High School Level). Possession of prescribed medications is prohibited. High school students may possess non-prescribed medications, but they may not possess prescribed medications except in transport to and from school. Prescribed medications must be turned into the nurse upon arrival at school. High school students may possess and use glucose tablets and inhalers according to the provisions of Rule 5600.2.

Profanity and Obscenity. Written or oral language that is reasonably offensive or repulsive to the person hearing the same and which is disruptive of the educational process.

Public Indecency. Behavior resulting in public indecency (see definition). This subsection shall apply only to students above grade five (5). Neb. Rev. Stat. §79-267(7).

Pushing and Shoving. The act of pushing or shoving another individual or individuals which creates a material interference with school purposes and is a deviation from acceptable normative behavior.

Physical contact that involves non-injurious behavior. Any physical contact that deviates from the acceptable norm or personal conduct that creates a significant concern yet does not involve injury.

Receiving Non-Prescribed Medications. Receiving non-prescription medications by high school students that are distributed by another student at school.

Repeated Offenses or Series of Prohibited Conduct. Two (2) or more violations of prohibited conduct, or violation of two (2) or more of the acts prohibited herein within the academic school year which constitutes a substantial interference with school purposes. Neb. Rev. Stat. §79-267(11).

Secret Organizations/Gangs. Participation or membership in any secret fraternity, sorority, club, association, or organization is prohibited. The wearing of any ring, pin, or insignia of such a secret organization is also prohibited. Organizations or gangs which initiate, advocate, or promote violence, drug or alcohol use, sex, criminal activity, or activities which disrupt the school environment or threaten the safety or well-being of persons or geographic territory, unique appearance, or language, are a substantial disruption to and material interference with the educational environment and are prohibited. The use of hand signals, graffiti, or the presence of any apparel, jewelry, accessory, or manner of grooming which, by virtue of its color, arrangement, trademark, symbol, or other attributes indicates or implies membership in or affiliation with such a group, constitutes a substantial disruption to and material interference with the educational environment, and are prohibited.

Sexual Assault or Attempted Sexual Assault. Any sexual assault or attempt to sexually assault any person. Sexual assault shall mean sexual assault in the first or second degree as defined in Neb. Rev. Stat. §§28-319 and 320. Neb. Rev. Stat. §79-267(8). Sexually assaulting or attempting to sexually assault any person, provided the student has received a citation by a law enforcement officer which involves the offense subject to this subsection, the student admits that he or she has violated this subsection, or a complaint has been filed by a prosecutor in a court of competent jurisdiction alleging that the student has sexually assaulted or attempted to sexually assault any person.

Sexual Contact. The intentional touching of another person's sexual or intimate parts or the intentional touching of another person's clothing covering the immediate area of the other person's sexual or intimate parts, without the consent of the other person. Sexual contact also includes the non-consensual touching by the other person of the actor's sexual or intimate parts or the clothing covering the immediate area of the actor's sexual or intimate parts when such touching is intentionally caused by the actor. The sexual contact must be such that it can be reasonably construed as being for the purpose of sexual arousal or gratification of either party. Neb. Rev. Stat. §§28-318.

Sexual Harassment. Unwanted or unwelcome activity of a sexual nature which materially interferes with or substantially disrupts the educational process. This may include, but is not limited to, unwanted touching, pinching, patting, verbal comments of a sexual nature, sexual name-calling, pressure to engage in sexual activity, repeated propositions, written messages, notes, cartoons or graffiti of a sexual nature, and unwanted body contact.

Student Identification. Behavior resulting in public indecency (see definition). This subsection shall apply only to students above grade five (5). Neb. Rev. Stat. §79-267(7).

Pushing and Shoving. The act of pushing or shoving another individual or individuals which creates a material interference with school purposes and is a deviation from acceptable normative behavior.

Physical contact that involves non-injurious behavior. Any physical contact that deviates from the acceptable norm or personal conduct that creates a significant concern yet does not involve injury.

Receiving Non-Prescribed Medications. Receiving non-prescription medications by high school students that are distributed by another student at school.

Repeated Offenses or Series of Prohibited Conduct. Two (2) or more violations of prohibited conduct, or violation of two (2) or more of the acts prohibited herein within the academic school year which constitutes a substantial interference with school purposes. Neb. Rev. Stat. §79-267(11).

Secret Organizations/Gangs. Participation or membership in any secret fraternity, sorority, club, association, or organization is prohibited. The wearing of any ring, pin, or insignia of such a secret organization is also prohibited. Organizations or gangs which initiate, advocate, or promote violence, drug or alcohol use, sex, criminal activity, or activities which disrupt the school environment or threaten the safety or well-being of persons or geographic territory, unique appearance, or language, are a substantial disruption to and material interference with the educational environment and are prohibited. The use of hand signals, graffiti, or the presence of any apparel, jewelry, accessory, or manner of grooming which, by virtue of its color, arrangement, trademark, symbol, or other attributes indicates or implies membership in or affiliation with such a group, constitutes a substantial disruption to and material interference with the educational environment, and are prohibited.

Sexual Assault or Attempted Sexual Assault. Any sexual assault or attempt to sexually assault any person. Sexual assault shall mean sexual assault in the first or second degree as defined in Neb. Rev. Stat. §§28-319 and 320. Neb. Rev. Stat. §79-267(8). Sexually assaulting or attempting to sexually assault any person, provided the student has received a citation by a law enforcement officer which involves the offense subject to this subsection, the student admits that he or she has violated this subsection, or a complaint has been filed by a prosecutor in a court of competent jurisdiction alleging that the student has sexually assaulted or attempted to sexually assault any person.

Sexual Contact. The intentional touching of another person's sexual or intimate parts or the intentional touching of another person's clothing covering the immediate area of the other person's sexual or intimate parts, without the consent of the other person. Sexual contact also includes the non-consensual touching by the other person of the actor's sexual or intimate parts or the clothing covering the immediate area of the actor's sexual or intimate parts when such touching is intentionally caused by the actor. The sexual contact must be such that it can be reasonably construed as being for the purpose of sexual arousal or gratification of either party. Neb. Rev. Stat. §§28-318.

Sexual Harassment. Unwanted or unwelcome activity of a sexual nature which materially interferes with or substantially disrupts the educational process. This may include, but is not limited to, unwanted touching, pinching, patting, verbal comments of a sexual nature, sexual name-calling, pressure to engage in sexual activity, repeated propositions, written messages, notes, cartoons or graffiti of a sexual nature, and unwanted body contact.

Student Identification. Failure of a high school student to present the school approved student identification card upon the request of a district staff member while on school grounds, in a vehicle owned, leased, or contracted by a school being used for a school purpose or in a vehicle being driven for a school purpose by a school employee or by his or her designee, or at a school-sponsored activity or athletic event.

Theft/Larceny. Stealing or attempting to steal property, or repeated theft of property. This will include school property lent to a student that is not returned upon demand by an authorized staff member and for which there is no reasonable justification for the failure to return the property. Neb. Rev. Stat. §79-267(2).

Threatening with an Object. Threatening with an object which looks like a weapon or an object that could be used to injure someone. To qualify as a look-a-like weapon, the object must closely resemble a real weapon in size, shape, and color even when examined up close.

Threats-Level One. Using a threat as part of a common expression or in a context that the recipient does not feel threatened, frightened, or coerced (e.g., Oh, I could just kill you for that or I will punch you in the nose).

Threats-Level Two. Using an expression or an implied or veiled threat with the intent of threatening, frightening, or coercing another and the recipient feels threatened, frightened, or coerced (e.g., I will kill you).

Threats-Level Three. Threatening to kill or injure another person or threatening to damage property with potential for personal injury, without possessing a weapon or other object that could kill or injure the threatened or intimidated person and the student describes how it will be done, including any threats that concern dangerous chemical substances, biochemical attacks, or bioterrorism.

Tobacco-Possession of or use of. Possession or use of tobacco or tobacco products.

Transportation of Medications. The possession, use, and transportation of prescribed and non-prescribed medications shall be in accordance with the following rules.

Truancy. Unauthorized absence from school. Neb. Rev. Stat. §§79-201 and 209.

Unlawful Activity. Engaging in any unlawful activity not specifically covered herein, which constitutes a danger to other students or school personnel, or interferes with school purposes or the educational process. Neb. Rev. Stat. §79-267(9).

Possession and Use of Fireworks. Use of lighting of firecrackers or fireworks of any description.
