- Furthermore, any and all references to ‘01 All Full-Time Active Administrators, Teachers and Nurses’ and ‘02 All Other Full-Time Active Employees and Part-Time Certified Staff excluding Full-Time Administrators, Nurses, Teachers, Paraprofessionals and Food Service Employees’ should in effect pertain to ‘01 All Full-Time Active Administrators, Teachers, Nurses, Part-Time Certified Employees and Salaried Non-Certified Employees’ and ‘02 Hourly Non-Certified Employees excluding Paraprofessionals, Food Service Employees and Employees in Class 1’
- Under ‘B. Class and Benefit Summary’, under ‘Class Number: 01’, the item entitled ‘Minimum Participation Required:’ is hereby deleted and replaced with the following:

‘Minimum Participation Required: 100%’

Rates: The premium rate will remain unchanged.

The above rates are guaranteed until the next plan renewal date. This rate guarantee will not pertain to adjustments in premium rate due to amendments requested by the Employer.

Continued payment of premium constitutes acceptance of this Amendment, which becomes a part of the entire contract. It shall continue in force under the same provisions that govern the entire contract. All other terms, provisions and conditions of the entire contract remain unchanged except as stated above.
